A representative from the Dunn County Museum Committee spoke during public comment regarding interest in preserving the Old City Hall (Old Gymnasium) building and exploring potential partnerships with the City of Dunn Center. The committee expressed interest in working with the City to explore funding opportunities and potential uses for the building, including historical preservation, community events, and possible use of the basement apartments. The committee also suggested a letter of intent from the City to demonstrate support while funding and partnership opportunities are explored. Council discussed the possibility of collaborating with the Museum Committee and forming a steering committee to further evaluate the project.

- Council reviewed two repair estimates related to the city apartments and city hall. Apartment structural repairs for \$14,781.73 and concrete crack repair near City Hall garage for \$550.16.

- Pavlicek moved to approve both repair quotes totaling \$15,331.89. Binek 2nd. Roll Call Vote: Medley, Pavlicek, Binek — Ayes. M/C.
